Member lets council know he is curious on what is happening with NE-16-057-02-W4M expired land, he states he does not have receipts for the improvements on the land member notifies council that he does not have the receipts as that was a while ago, the quarter in question is a mile and a half

Member states he can get a receipt for work done fencing a mile and a half and it isn't near \$1,200.00.

The compensation \$10,600.00 on the lands that have been improved

NE-15-057-02-W4M what is happening with this?

Shirley is not comfortable with the environmental monitor going to inspect saying there is not a dugout but member does speak on there is being a dugout

And he can show it to council if they would like to see it.

Council can either return the land to the member or compensate for the improvements done but landholder cannot have the land as she is at her maximum limit of land to be held so the only other option is compensation

This is currently an allotment that are good for 10 years and if we did the renewal we would not be able to revisit this until 2027 it has been 10 already so the renewal will be for 5 years, Chairman Terry suggests we as a council should have put money into the budget to deal with these land issues so that we are not stuck with no answers for the members that are currently holding too much land and not having affidavits for cattle and or animals on the lands in question.

LTA Funding Labor Market Training

Employment Services Director lets council know that the employment services has received \$25,000.00 in December.

Councilor Dwayne asks is there a certain way that you are spending this money.

They are using the STI policy and templates, Councilor Dwayne asks if employment services has spent STI monies and Director confirms yes that was through the STI dollars.

The individual in question is doing fall protection course

We spent \$2,210.00 in Q3, Marie lets council know that they are doing short courses, Arlene asks how you are identifying who has gone for training?

Employment services hands out a breakdown of all monies spent and a list of all exposure courses and which members have attended.

Some of the monies are already dedicated two youth trained in wastewater management, and director is working with Portage College on getting this training in for two members, the members need the entry level training before they are eligible to carry on.

Fire Dept. hasn't been busy but has been still doing fire drills

As for the medic side things have been quite busy

Jeff reviews his report for council, the fire department has not seen any incidents since the summer months but has been doing regular Fire Drills at the Headstart/Daycare for their safety as well as for the reporting to governing agencies.

As for the Medic side of things, Emergency services has went through some rough patches especially during the Christmas season as there was a rush to have a bunch of work done so

we were shorthanded to the point where we had to call a former employee and myself to work through the rush. Things are less busy now that we have a medic specific for community. Since December we have had thirty-two medic calls from minor all the way up to life threatening. Our medics are doing a great job keeping up with the calls.

Any questions on the emergency services report

Dwayne-Nothing on the report, but other issues that the administrator needs to be present so that these concerns can be addressed properly

Who oversees the medic side of things? Jeff says it's supposed to be him

What policy do the medics follow? Leon speaks in on medics and policy it is too expensive to cover medics under the HR policy, they need their own policy.

The community medic will be on five days a week, the oilfield medics are paid based on ticket only

Councilor Dwayne suggests maybe the medics need to be an entity again to clear up further misunderstandings.

Councilor suggests having a medic meeting separately with Ryck and Council

He has two medics coming back from training that will be fully capable of working weekends.

Chairman speaks on HR Policy for Medics and Leon speaks that it is in the works chairman suggests bringing this forward so that council can review.
