Nicole has been meeting with the Dept Heads and working on their budgets. Proposal for next year for EDO will be more of a proposal writer and grant finder. Housing will need to be looked at. Ryck is still waiting to see the budget. Ann had budgeted for 2 youth workers.

Recreation position- will be getting youth in there as the position turns into a youth position anyways and would work better that way. Ann will clarify. Department heads can argue their case when they bring forward the budgets to Council. Nicole will get a breakdown of housing costs.

Terry- FLMS Future fund updates will go to Dwayne. As of Oct FLMS future fund is at \$4, 562,316.74 book value. LTA Member's contribution, have we met our mark? No, we haven't met our estimated mark for contributions. We are around 50%, what happens to LTA funding that we don't get?

Arlene- Parks & Recreation, is over, Nicole needs to fix the budget lines, needs to create a second class.

Dwayne would like clarity on whose wages can be presented in the budget, are they FOIP?

Called back to order at 10:35 a.m.

Emergency Services- Jeff Turcotte in at 10:36 a.m.

Jeff- was away for a while but is back now, Fire side haven't had much will be doing prescribed burns. Fire drills have been going smoothly, added outreach to fire drills. Northlands does their own separate drills, they haven't responded to Jeff. Getting grant for upgrades for communications. Has received 4 quotes on communication upgrades costs range from \$30,000.00 to \$70,000.00. Jeff has 2 demo AFRRCS radios. Nothing to maintain on the radios no infrastructure or extra costs.

Are communities involved or aware of the changes? Not directly to community members just in the Emergency services municipal departments. Jeff is testing the radios for boundaries, each radio is \$1800.00 and \$2000.00 for the mobile and fixed

radios. Jeff has put in his budget and grant will be \$100,000.00 and another grant is \$70,000.00 and will also be looking into another grant. Radios have warranty, and there are repair sites in the local towns.

Medics- Oilfield work has been busy since Harvest is back on settlement. Community medics will be more visible and will be working more in the community and attending events. Put a posting out for a part time medic. Discussion on past medic leaving medic vehicle, too much mud on vehicle and abandoned the vehicle, employee was terminated. Protocol on vehicles being abandoned, employees must wait on tow and stay with vehicle or they will be terminated. Has 2 resumes for community medics. Jeff will be taking a course on the new fire suppression systems in the new Administration building, so Jeff can do all inspections. Jeff will also be doing Fire extinguisher course to do inspections on those as well.

Jeff exited council chambers Leon joined the meeting at 10:54 a.m.

Leon brought forward the new housing agreement for Danielle Daniels.

Are new homers provided with new housing package? Blue prints can be provided to home owners but will be kept in their housing file.

Arlene- in practice, it's always been 5 council signing, add motion attached if just the Chairperson is to sign.

Housing agreements and anything with motions need to have motion attached to the policy or agreement. Leon will redo the back page of the agreement for housing. Individuals who have been awarded the duplexes are aware. Leon will revisit letters sent to individuals since they do have to pay the first and last month's rent.

Terry will be joining a meeting with Leon next Tuesday in Edmonton, Dwayne would like to see pictures.

Leon is also looking at the pre-fab wooden cabins, will present update to council once finished.

Dwayne would like clarity on repairs for windows for Kelly Bowen, Leon did talk to the member informing him that there is no money in the budget for repairs.

Going forward all repairs from prior have been done and nothing will be getting repaired going forward until new budget comes in, and will not being going back for past applicants.

Terry-looking at doing a housing assessment and repairing old homes, look at taking the future fund to the members to see if they would use it for fixing homes.

Dwayne doesn't agree to use the future fund, it's for investments to get money back. Morris disagrees, we are elected to do this for them. Terry would like them to have input and do a referendum.

Administrator- Leon and Administrator can look at options for the future fund, Leon can look at getting renovation options. How much money do you want to put forward, how much to spend? Different options to address single members. Leon will bring forward options.

Can use different pots of funds for numbers.

Reno's and new homes and a focus on singles with one child and over-crowding families and bachelors. Leon would like to build a strategy for council, with financial options. Leon sent an email to Victoria Brown regarding habitat for humanity. Leon would like to design something for the settlement similar.

Terry would like to set a meeting with Leon in the New Year for new housing in January 4, 2017.

Dwayne- where are we putting these new homes.

Administrator- we need to reclaim all the burnt sites.

Arlene- when will Riel beach be done? Leon- washrooms should be done in 2 weeks, was waiting on the electrician. Won't be doing the testing until spring. Project is under budget so far.

Terry will call a Riel Beach mtg Dec 5th, 2016.

Leon exited chambers and Tanya Fayant, Srgt. Barry Laroque and Constable John Garnier joined the meeting at 11:31 a.m.

RCMP brought forward a breakdown of service calls, Laroque is looking at options for Frog Lake as they have the highest call rate for services. Arlene suggests offering support to them would it help them? Laroque- letters of support may help them.

Terry- would council agree to a letter of support for Frog Lake, Tanya will draft a letter and will communicate with Barry before its approved and sent off.

Laroque- starting to get a new group of young people, stolen vehicles have been around out on the settlement.

Discussion on troubled youths and unhealthy homes.

Tanya suggests the 3 households need to get healthy or go.

Shirley- How do we proceed? Write a letter and ask them to come in? Include Region 10, RCMP, tribal chiefs and families? Tanya will set a date with parties involved.

John- will be getting information for members on crime stoppers, as crime stoppers calls are anonymous.

Removal of a non-member, what's the process? Court order then boundary specified, has to be done by lawyers and then sent to the RCMP for execution. Can send a public building notice of trespass and ban from public buildings. Settlement can ban people from public buildings and revoke public access. Council consensus is to have Administrator get information on notice of trespass and banning individuals from public buildings.

Rvck- Scheduling with security.
