Introductions of Council and Administration.

Paula Campbell introduced herself as the operations manager for Maintenance. Councillor Shirley Calliou speaks on the south road requiring fixing, the whole south road from the monument coming into the Fishing Lake Metis Settlement needs major repair. Council considers this road very dangerous as there has been multiple deaths on this road.

Council has addressed their concern with this road to Alberta Transportation in the past and has never received any answers back. Tania Daniels the Administrator for the Fishing Lake Metis Settlement sent a letter to Alberta Transportation and has yet to receive a response. Paula asked if it was the letter with invoices attached, Administrator Tania Daniels agreed that yes the letter did have invoices attached for the Maintenance on the road that was completed by the Fishing Lake Metis Settlement.

Paula notified Council that she only oversees the maintenance for Alberta Transportation. Councillor Bill Parenteau would like to know what the budget is per year for the maintenance of this road. Paula states she cannot disclose that information as Alberta Transportation has a contract with Emcon for the maintenance of the south road.

Paula notified Council that in 2021 the grader was sent out to address the ripples on the road. Councillor Bill Parenteau has spoken to Ralph Gilbertson on different occasions and he had stated he had plans for the road. Councillor Bill Parenteau states that everyone you speak to has the same complaint in regards to the road. Alberta Transportation has a budget to follow, Councillor Bill Parenteau would like to know if its possible to have the road checked. Paula notified Council that the road is checked three times a week by Emcon.

Chairperson Charles Gladue would like to know what is spent per year on monument road. Paula notified Chairperson Charles Gladue that she is not permitted to disclose that information.

Councillor Bill Parenteau would like to know if there was an assessment done on the roads is there an issue in Alberta to spend this money? Paula notified Councillor that they do have a plan to address the road.

Councillor Bill Parenteau does not know why the funds are not utilized to fix the roads, he states to make the road safe and put the money where it needs to be.
